#### (2) CRAFT DEMONSTRATION AREA



- Coordination with artisans to allocate the stalls.
- Stalls to be dressed up by the night of 31<sup>st</sup> January 2018.
- Provisions for seating on the ground/ floor level for the artisan.
- Provisions for display of craft products.
- Names and other signage for introducing the artisan
- Basic furniture of one large low table, standard racks and moodas etc for viewers.
- Security arrangements to avoid shoplifting, at the exit and at night.
- Light music in the background
