FUEL Communications & Marketing Solutions	<ol> <li>It has already been clarified in pre bid meeting that transportation of scanners will be handled by NIFT itself, and as per tender it seems that one scanner can be transported to only two locations in a city for 1.5 months each. Our question is that suppose if we observe that response at a particular location is not coming out as desired, can we sift the scanner to a new location. Can we move scanners to more than two locations at a city instead of just two venues? If yes, who will pay for the expenses of transportation to more than two locations?</li> <li>PF issue was discussed in pre bid meeting. We are not registered with EPFO because it is not legally mandatory for us considering our staff size.</li> <li>As per tender doc, insurance of equipment's is necessary. Are we supposed to insure scanners also? If yes, we need cost of scanner because that will decide insurance cost.</li> <li>As per central go by guidelines, bidders registered as Small and Medium enterprises are not required to pay EMD.
