Terms and Conditions: -

- 1. The printer should have licensed software for colour correction / printing compatible with Adobe Suite (In Design / Illustrator).
- 2. The printer will depute technically qualified executive to coordinate the job with CCC Department of NIFT-Head Office.
- 3. CCC Department of NIFT- Head Office would provide the soft copy of complete text in the layout to the printer.
- 4. The design and layout of the NIFT Admission Prospectus-2022 will be provided by CCC Department of NIFT-Head Office. However, the final artwork of the complete Admission Prospectus will be prepared by the printer in consultation with the CCC Department of NIFT-Head Office.
- 5. The final corrections in the layout of NIFT Admission Prospectus (if any) will be carried out by the printer.
- The final colour dummy will be approved by the CCC Department of NIFT-Head Office before printing.
- 7. The printer will supply all the copies of the Prospectus in proper packaging (water proof and fabric packing over carton).
- 8. The printer will provide a soft copy of the complete Prospectus 2022 to the CCC Department of NIFT Head Office and a final pdf before it goes in print.
- 9. Please attach paper samples with technical / manufacturing / paper details along-with the quotation.
- 10. Please note that specification may vary and number of pages may also increase or decrease. If number of pages increases or decreases, the payment will be released / calculated as per actual number of pages printed of NIFT Admission Prospectus on the basis of rates quoted by the L-1 printer for + / 4 pages.
- 11. The first proof of the material should be submitted within 5 days from the date of submission of relevant material by the CCC Department of NIFT-Head Office.
- 12. The printer shall print the NIFT Admission Prospectus on the paper specified. The printer will provide colour laser printouts of the first dummy + final dummy of the NIFT Admission Prospectus to Head CCC Department of NIFT before going to final printing at the printer premises.

- 13. Delivery of 500 Nos. of printed NIFT Admission Prospectus in proper packaging required to be completed within 15 days at NIFT-Head Office and 16 outstation NIFT Campuses (as per list attached at **Annexure II)** from the date of approval of final proof given by CCC Department, NIFT Head Office.
- 14. Printer who will be awarded the work is required to submit the self-attested photocopy of the Invoice for purchase of paper and shall have to give in writing in the following Performa:-

"Certified that the paper procured from the M/s. ----- is actually used in printing of NIFT Admission Prospectus - 2022 at the time of submission of bills."

15. No other charges will be given for freight etc.

Payment Terms: Payment will be released on delivery of 500 Nos. of Admission Prospectus - 2022 subject to satisfactory report from Head - CCC, NIFT Head Office and submission of original Invoice. TDS will be deducted as per the rate applicable.

Penalty:

A Penalty of Rs. 500/- per day subject to maximum of 10% of the bill on account of delayed supply of the material will be charged in case, the supply is not made within the stipulated time and thereafter NIFT can terminate the whole contract. In case of the delivery of any defective / inferior printed material mistake suitable penalty will be imposed / deducted from the final payment.

Validity:

Your rates should be valid for a period of 3 (Three) months from date of opening of quotation.

Technical Documents Required with the sealed quotation:

- The bidders should have their own Printing Press located in Delhi / NCR region with in-house facility including designing / dispatch etc. to execute the job as required. (Submit self-attested copy of proof).
- 2. Copy of Registration Certificate in support of GST No / PAN No. & Validity etc. (Submit self attested copy).


