The Office of International & Domestic Linkages invites student applications for International Summer Programme for Schweizerische Textilfachschule (STF)/ Swiss Textile and Fashion College, Zurich, Switzerland under "UDAAN"- NIFT Scholarship Scheme for Foreign Studies.

Kindly forward this information to CCs of all Departments at your Campus and facilitate meetings/ talks with your campus students there by informing them about Semester Exchange opportunity under "UDAAN"- NIFT SCHOLARSHIP SCHEME FOR FOREIGN STUDIES.

Minimum of 7.0 CGPA is required for applying for Summer Programme. Regular students belonging to economically weaker sections of NIFT fulfilling the criteria of "SARTHAK" NIFT Financial Assistance Scheme", are eligible for consideration under the "UDAAN"- NIFT Scholarship Scheme for Foreign Studies". The benefits of this Scheme shall not extend to NRI/ NRI sponsored students. The finally selected students will receive sponsorship for the approved course fees for the period along with travel and subsistence allowance.

The amount under the following heads will qualify for 100% financial assistance depending on the eligibility criteria:

- Tuition Fees on actuals
- Hostel / dormitory charges on actuals
- Technology Fee
- Student Activity Fee
- Recreation & Athletics Fee
- Health Services
- Health Insurance
- Travel expenses on economy class (as per actual).
- Visa Fee
- Subsistence allowance

The system is online at CMS. NIFT application format to be filled in by the students will be uploaded on CMS and the CGPA would require to be verified by the respective Centre Coordinators. The student will require to upload all required documents on CMS.

The last date of filling the application by students on CMS is 24th March 2023.

The selection process will include three level of scrutiny. Two level of scrutiny will happen at campus level. (Policy attached for reference)

Second level committee will shortlist 12 candidate per campus for onward submission to NIFT Head Office by 3rd April 2023.

Third level of Scrutiny will be held at NIFT-HO on 05 April 2023 (We are checking for the availability of an external committee member for the meeting).

If this opportunity clashes with any other academic requirement like Industry Internship/ Cluster, students are required to complete these requirements in consultation with their CCs.

As per the policy in the Academic Manual (pg-212) students applying for exchange programme shall submit a security deposit of Rs. 15,000/- through a PDC (dated 24th April 2023) in favor of NIFT.

All students applying for International opportunities will also pay a facilitation fee of Rs. 2000/-. The cheque of Rs 2000 as the application processing fee shall be deposited in I&DL account of the concerned NIFT campus.

The system is online at CMS. NIFT application format to be filled in by the students will be uploaded on CMS and the CGPA would require to be verified by the respective Centre Coordinators and further approvals of CI&DL & Directors as per CMS would be done.

The list of students interested in applying for the programmes should apply online & inform respective CI&DL. A single merit list shall be drawn of all applications received from campuses against available seats by taking merit into account at HO. **The last date of filling the online application by students in CMS is 24th March 2023.**

All the CI&DL's are requested to kindly facilitate maximum student entries from their respective Centre's.

Short listing of candidates for sending to the foreign university shall be done by SIAC-I&DL at HO. The eligibility and selection criteria for selection of students shall be the same as being followed for summer programme.

As per the policy in the Academic Manual (pg-212) students applying for exchange programme shall submit a security deposit of Rs. 15,000/- through a PDC (dated 24.04.2023) in favor of NIFT.
