NOTICE INVITING TENDER

E-tender are invited on behalf of the National Institute of Fashion Technology from reputed and eligible agencies who have carried out similar work with Govt. departments/PSUs/Pvt./MNCs, for "Renovation / Up-gradation Washroom (Ladies & Gents) 2nd Floor B - Block at NIFT HO, Hauz Khas, New Delhi." The terms and conditions of the contract which will govern the contract are contained in the General terms and conditions applicable to the contract are detailed in the tender form and its schedules.

NIFT shall have the authority to cancel the tender process if NIFT does not find a suitable tender. NIFT shall have the right to call for fresh tender in such circumstances, where in tenderers who have bid in the previous tender, shall have the right to participate in the fresh process. The tenderers shall have no right to challenge the authority and decision of NIFT to cancel the tender process for the reasons deemed fit by NIFT.

- (e) The agency should ensure that it complies with the requirements as per works before applying for tender.
- (f) The technical bid must contain the technical bid in prescribed Performa along with all relevant documents in support of eligibility and experience criteria. The financial bid must contain only the financial bid. The financial bid shall include all the charges including all taxes etc to complete the work in all respect. NIFT will not accept any claim other than mentioned in financial bid.
- (g) The technical bid will be opened at in the office of Estate Engineer, HO, New Delhi on 14.02.2025 at 03.30 P.M. in the presence of the bidders/ their authorized representatives who wish to be present. The Financial bid will be opened on the date which will be communicated to only those bidders who are found to be technically qualified after evaluation of technical bids.
- (h) The interested agencies are advised to read carefully the entire tender document before submitting their tender and the tender documents (including signed copy of NIT) not received online in prescribed format and/or are found incomplete in any respect shall be summarily rejected.

3. INSTRUCTIONS TO TENDERERS: -

The tenderers are requested to follow the below mentioned instructions:

- 1. Offers on original tender document will only be considered. Offers submitted by fax or in any manner other than specified above shall not be considered. The bids shall exactly be according to the prescribed formats. Modifications/Rewording of formats shall not be acceptable.
- 2. All documentations are required to be in Hindi/English.
- 3. Tender should be filled with neat legible and correct entries. Indistinct figures, erasures and alterations are not permitted in the tender.
- 4. Failure to comply with these conditions will result in forfeiting of the tender. Please cross out any mistakes and rewrite the same and counter sign.
- 5. Incomplete tenders, amendments and additions to tender after opening and tenders submitted after due date shall liable to be ignored.
- 6. Cost involved in submitting the bids, attending the tender opening meeting, arrangements for the demonstration /presentation etc. shall be borne by the bidder.
- 7. No tenderer shall be allowed to withdraw the tender rates after opening of the tender. If any tenderer withdraws the rates, he shall be disqualified from participating in any future tender of the Institute.
- 8. Rates should be offered unconditionally and if rates are submitted with any condition the tender shall be rejected.
- 9. Criteria of selection of lowest vendor will be the L1 overall for the work.

4. Defect Liability Period:-

The work/ materials of the contractor shall be under 12 months Defect Liability Period (DLP). Any defect/s noticed during the defect liability period shall be rectified by the contractor without any cost to NIFT Campus, Hauz Khas, New Delhi, failing which the Security Deposit of the Contractor will be forfeited. The contractor may also be debarred from any future tendering process in the institute for reasons assigned hereinabove.

5. Detail of required Experience Certificates /Work orders: -

The Applicant to meet the following minimum experience:

A. Work orders/ Experience (As mentioned below) of having successfully competed similar work during last 7 (Seven) years ending December 2024. & estimated value of the work is Rs.19,58,299/-.

A (1) One similar completed work costing not less than 80% of total tender estimated cost.

Or

A(2) Two similar completed works costing not less than 60% of total tender estimated cost.

Or

- A(3) Three similar competed works costing not less than 40% of tender estimated cost.
- B. Definition of "Similar Works" Experience in carrying out similar nature work i.e. Relevant Toilet repair/renovation Works as described in the BOQ in private sector or Govt. organizations/ PSU's/ MNCs.

TERMS & CONDITIONS:

- 1. No paper shall be detached from the tender.
- 2. If any date mentioned above happens to be a holiday, then the next working day will be the relevant date.
- 3. The name and address of the tenderer shall be clearly written in the space provided and no overwriting, correction, insertion shall be permitted in any part of the tender unless duly countersigned by the tenderer. The tender shall be filled in and submitted in strict accordance with the instructions laid down herein; otherwise the tender shall be liable to be rejected by the NIFT unilaterally without assigning any reason or giving explanation to this effect.
- 4. The tender shall be liable to be ignored/rejected if complete information is not given there-in, or if the particulars and data (if any) asked for in the Schedule to the tender are not filled in or any wrong/false or incorrect information is given or any material thing is concealed or manipulated therein.
- 5. If the tenderer withdraws or amends impairs or derogates from the tender in any respect within the period of validity of his tender or tenderer fails to furnish the performance guarantee as required in the contract within the stipulated period, NIFT shall be entitled to initiate appropriate legal proceedings against the tenderer for the losses suffered by it as a result of the same.

6. **Dispute Resolution:**

- a. If any dispute (s) or difference (s) of any kind whatsoever arise between the parties, the parties hereto shall negotiate with a view to its amicable resolution and settlement through a committee appointed Competent Authority, NIFT –HO with mutual consent of the other party.
- b. In the event no amicable resolution or settlement is reached between the parties within 30 days after receipt of notice by one party,
- c. in that event, the same shall be adjudicated by the Courts of Law at New Delhi.
- 7. **Selection Criteria:** The work will be awarded to L1 vendor on overall basis. The determination of lowest bidder will NOT be on individual rates of financial bids. Rather it will be on overall basis of Grand Total of all items with GST.

The following documents / information shall be attached along with Technical Bid as follows:

- C. Duly certified by CA copy of Average annual financial turnover on construction works should be at least 50% of the estimated cost put to tender during the immediate last three consecutive financial years.

- 8. Tender shall be accompanied by all the relevant documents covered in the tender.
- 9. The full & final payment shall be made by the purchaser i.e. NIFT only after completion of work. No advance payment will be made for supply of materials/machines/ equipment, however payment for running bill may be released (at least completion of 50% works)
- 10. The successful tenderer shall deposit **5**% of the quoted price of the Tender as Performance Security with NIFT within 10 days after award of work in the form of [Insurance Surety Bond] Account Payee Demand Draft (in favour of NIFT, New Delhi), Fixed Deposit Receipt from a Commercial bank, Bank Guarantee [including e-Bank Guarantee] from a Commercial bank or online payment in an acceptable form. Performance Security shall remain valid for a minimum period of sixty days beyond the date of completion of all contractual obligations as per GCC. No interest shall accrue on this deposit.
- 11. The bid security (also known as Earnest Money) may be accepted in the form of [Insurance Surety Bonds] Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee [including e-Bank Guarantee] from any of the Commercial Banks.
- 12. The agency shall be liable with regard to compliance of all laws, regulations, rules & directions given by any statutory or constitutional authority for the time being in force in the state of Delhi.
- 13. The quoted rates shall be inclusive of all tax. As applicable and no extra shall be payable on this account.
- 14. The date of start of work will be reckoning is 10 days from the date of issue of work order.
- 15. - 16. If the work is not completed within the stipulated time period (45 days), in such case liquidated damages @ 1% per week shall be charged and deducted from the bills of the agency subject to maximum of 10% of the contract / bill value.
- 17. The materials supplied and proposed to be used in the work shall be of requisite specifications as specified in NIT, as per specification given in BOQ.
- 18. Contractor shall have to comply with the provisions of (a) the contract labour (Regulation Abolition) Act. 1970 and (c) minimum wages Act. 1948 of the notification thereof or any other laws relating thereto and the rules made and order issued there under from time to time.
- 19. Agency is required to verify all the material from Estate Engineer before execution.

- 20. The quantities of work given in the Bill of Quantities (BOQ) are approximate to give an idea of work. Work shall be carried out as per the given design / specifications and the quantities may vary on higher or lower side. The contractor shall execute the varied quantity of work on the quoted rates. The payment shall be made as per actual measurement of work Contractor shall be solely responsible for safety of his workers, working at site by following all safety norms in the trade.
- 21. The contractor may apply to the Estate Engineer within 14 days in writing for extension of time stating the grounds that hindered the execution of work.
- 22. The Earnest Money shall be forfeited:
 - a) If the Bidder withdraws the Bid during the period of Bid validity.
 - b) In case of a successful Bidder, if the Bidder fails within the specified time limit to sign the agreement.
 - c) During scrutiny or at any stage of bidding or even after award of contract, if it comes to the notice to NIFT that the credential or any other papers found incorrect/manufactured/fabricated. d) If the bidder fails to submit the Performance Security within ten working days from the date of issuance of work order.
- 23. **Time of Completion: -**The work shall be duly completed within 45 days from the date of receiving of work order by the agency.
- 24. All risks of loss or damage to physical property and of injury and death which arise during and in consequence of the performance of the Contract other than the excepted risks are the responsibility of the Contractor. Excepted Risks are:

 - (iii) Ionizing radiations, or contamination by radio-activity from any nuclear fuel, or from any nuclear waste from the combustion of nuclear fuel, radio-active toxic Explosive, or other hazardous properties of any explosive nuclear assembly or Nuclear component therefore.
 - (iv) Pressure waves caused by aircraft or other aerial devices traveling at sonic or Supersonic speed.
 - b. Loss or damage due to the use or occupation by the Employer of any section or part of the Permanent Works, except as may be provided for in the Contract.
 - c. loss or damage to the extent that it is due to the design of the Works, other than any part of the design provided by the Contractor or for which the Contractor is responsible.
