4. **The price quoted for hiring photocopier should be inclusive of all taxes.**
5. **5000 nos. (Five Thousand) copies per month per machine will be covered.**
6. No over writing, correction, insertion shall be permitted in any part of the Tenderer.
- 7 A Demand Draft of **Rs. 15,000/- (Rupees Fifteen Thousand only)** is required to be deposited as Earnest Money Deposit in favour of **NATIONAL INSTITUTE OF FASHION TECHNOLOGY, New Delhi** along with Sealed Tender (Technical Bid). Any bid not accompanied by required EMD, shall be deemed to be invalid & will be rejected by NIFT. The earnest money of successful bidder will be returned without interest subject to deposit of security deposit amount.
 - 7.1 The EMD shall be returned without interest:
 - (i) To the unsuccessful bidders after the award of contract.
 - (ii) In case bidding process is terminated by NIFT for any reason.
 - 7.2 **The Earnest Money Deposit of the successful tenderer shall be forfeited if the tenderer:.**
 - a) Withdraws tender offer before finalization of the same.
 - b) Fails to accept the tender, if his/their tender is accepted by NIFT Head Office.

- 22 The sites where the machines have to be installed, may be inspected during working hours on any day if required by the bidders.
- 23 The contractor will maintain history sheet of every systems/equipment provided under contract with detailed specification. Details of all minor/major, routine/preventive repair/maintenance job undertaken shall be entered into the history sheet.
- 24 Complaint feedback/performance report: The contractor will maintain all records of the complaints in a Register.
- 25 Prices may be quoted on per unit basis for the items as per annexure-II.

26 Termination

The contract can be terminated by either party giving one month notice to the other party. Nevertheless, NIFT may terminate the contract of the contractor without any notice incase the contractor commits a breach of any of the terms of the contract. NIFT's decision that a breach has occurred will be final & shall be accepted without demur by the contractor.

- 27 NIFT shall in no way be responsible for any default with regard to any statutory obligation and the contractor will indemnify NIFT in case of any damage or liability which may arise on account of action of contractor.
- 28 The payment shall be made on monthly basis and TDS as applicable will be deducted.
- 29 All statutory obligations under various laws from time to time will have to be borne by contractor for which no extra payment shall be made to him at any time during the contract period.
- 30 The contractor will deploy one Mechanic at NIFT Campus to ensure fault free working of all photocopiers.
- 31 If the performance of the contractor at any time during the contract period is not found satisfactory and does not improve the performance even after a written notice from the Administration Department, the contract shall be terminated without any further notice with forfeiture of Security Deposit and the contractor will be blacklisted for future work.

32 Conciliation/Arbitration

- i) If any dispute(s) or difference(s) of any kind whatsoever arise between the parties, the parties hereto shall negotiate with a view to its amicable resolution & settlement through a Committee appointed by DG-NIFT.
- ii) In the event no amicable resolution or settlement is reached between the parties within 30 days after receipt of notice by one party, then the disputes or differences as detailed above shall be referred to & settled by the sole Arbitrator to be appointed by DG-NIFT.
- iii) The arbitration proceedings shall be in accordance with the provisions of Arbitration & Conciliation Act, 1996 & Laws of India as amended or enacted from time to time.
- iv) The venue of the Arbitration shall be New Delhi.
- v) The Arbitrator will give the speaking & reasoned award.

33 Applicable Law & Jurisdiction :

All matters connected with this shall be governed by the Indian Law both substantive & procedural for the time being in force & shall be subject to the exclusive jurisdiction of Indian Courts at Delhi.

- 34 NIFT reserves the right to annul the bidding process at any time period to award of contract including rejection of any or all bids after the same have been received, without thereby incurring any liability to the affected bidder or any obligation to inform the affected bidder/s on the ground of NIFT action.

35 Validity :

- The bid validity should be minimum for a period of 06 months from the opening of Financial Bid.
- The Quoted rates should be valid for a period of one year from the date of Work Order, the repeat order can be placed if required on same terms & conditions and mutually agreed consent by both parties.
