1. The sealed tender super-scribed with **"Tender for sale of used Maruti (SX4 VXI BS3) DL 3CBM 1984 (2009)**, duly addressed to the **Director (Admin), NIFT Head Office**, NIFT Campus, Near Gulmohar Park, Hauz Khas, New Delhi 110016 along with the Earnest Money Deposit (EMD) 'Annexure – A' should be **submitted/dropped in tender box kept at NIFT Head Office, 2<sup>nd</sup> Floor, NIFT Campus, Near Gulmohar Park, Hauz Khas, New Delhi 110016 on or before 03.10.2019 up to 10:30 AM.**
2. **Tender must be submitted with duly attested photocopies of the following documents :-**
  - 2.1. **Individual Bidders:**
    - (a) Photocopy of residential Proof (Passport, Driving License, Voter Identity Card, Ration Card).
    - (b) Photocopy of PAN/GST
  - 2.2. **Firm / Partnership Firm / Company etc.**
    - (a) Photocopy of registration certificate of Firm / company / Partnership deed.
    - (b) Photocopy of PAN Card/GST
3. Offers should be submitted in **Price Bid Format** only
4. Any offer received without the EMD and/or without prescribed tender form will not be considered.
5. The delivery / handing over of vehicle will be on proof of valid Identification Card of the purchaser.

6. After the date of possession of vehicle by the successful bidder, NIFT will not be liable in any manner regarding its use & misuse.
7. The bid will be considered in favour of the person quoting the highest rate in respect of the subject car, provided the same is accepted by the Institute and have submitted valid requisite documents.
8. The bidders should quote the amount of purchase of the subject car both in words and in figures. If there is any difference between the amounts mentioned in figures and that of in words, the rates quoted in words alone will be taken into account and accepted on record.
9. The highest bidder shall have to deposit the bid amount in the form of Demand Draft / Pay Order drawn in favour of NIFT payable at New Delhi within 3 days on receipt of confirmed sale order from NIFT.
10. It shall be presumed that the bidder has fully inspected the car before submitting the quote. NIFT shall not be responsible and shall not entertain any complaint whatsoever after closing the tender.
11. Earnest Money will be forfeited in case the successful bidder fails to make the balance payment of vehicle within the stipulated time.
12. The Earnest Money deposit will be returned to the unsuccessful bidders after the acceptance of the offer to the successful bidder. However, no interest shall be payable on EMD.
13. NIFT reserves the right to accept/reject any bidding, to postpone / suspend in full or part thereof or to cancel the whole process or part thereof the sale at any time without assigning any reason.
14. GST & TCS at applicable rates and transfer charges and other RTO fees, if any, will have to be paid by the successful bidder as per the Government Rules over and above his / offer.
15. If the highest quoting firm fails to honor the bid; the acceptance of offer will be cancelled & its EMD will be forfeited. In such event, an opportunity shall be given to the next highest quoting eligible bidder (H-2 quoting party) to complete the bid provided it is prepared to accept the prices offered by the H-1 party.
